Please note that the registration of the application does not confirm its integrity. The process of assessing the parameters of the product can be launched only after completion of the prescribed data and delivery of all required supporting materials acc. to article 21 para. 2 of the Act.

## Information for the applicant/manufacturer - voluntary certification, or testing

The assessment and verification of constancy of parameters according to the CPR or the Act covers only those (mandatory) characteristics (or at least one characteristic of them) having a relevance to the basic requirements for works and therefore referred to in the technical specifications. However from a marketing viewpoint it is recommended to have also a voluntary certificate or at least test reports issued by an independed third party (accredited certification body or test laboratory) covering parameters of additional characteristics that might attract customers' interest in your product as opposed to your competitors having only the mandatory characteristics certified.
